NOTICE IS HEREBY GIVEN that the Board of Supervisors of Heidelberg Township, York County, Pennsylvania, intends to consider for adoption and to vote upon Ordinance No. 2026-01, summarized below, at a meeting to be held on February 4, 2026, at 6:00 p.m. (prevailing time), at Porters Sideling Fire Company, 1199 Porters Road, Spring Grove, Pennsylvania 17362.

The proposed Heidelberg Township Ordinance No. 2026-01 is entitled and summarized below:

AN ORDINANCE OF HEIDELBERG TOWNSHIP, YORK COUNTY, PENNSYLVANIA, AMENDING ORDINANCE NO. 88-2, AN ORDINANCE ESTABLISHING MAXIMUM SPEED LIMITS ON CERTAIN STREETS, AS AMENDED

The proposed Heidelberg Township Ordinance No. 2026-01 amends Ordinance 88-2, as amended and supplemented as follows:

The road previously identified as Hillview Road from Hoff Road to Kraft Mill Road shall be identified as Hoff Road and the road previously identified as Kraft Mill Road shall be amended to be identified as Porter's Road; and

Maximum permitted speed shall be lowered from 35 mph to 25 mph on Laurel Woods Lane, Rosepointe Way, Trolley Road, Wildasin Drive, Danner Drive, Potter Court, Manor Drive, Tamarind Drive, Yingling Drive, Deer Run Court, Kelly Avenue and High Rock – N, E, W.; and

Maximum permitted speed limit of 25 mph is established for Acorn Road, Shellborne Road, Locust Road, Hayrick Road, Mountain Road, Clinton Court, Oakwood Road, Faith Way, Charity Way, Hope Way, Gardener Road, Laurel Woods Court, Mountain Court, Amy Way, Gregorey Road, Laurel Summit, West Side Drive, Liberty Road, Carlton Avenue, and Lexus Drive; and 35 mph for Glatco Lodge Road; and Packing House Road.

And provides for: Repealer, Savings, Severability and Effective Date.

ORDINANCE 2026-01

AN ORDINANCE OF HEIDELBERG TOWNSHIP, YORK COUNTY, PENNSYLVANIA, AMENDING ORDINANCE NO. 88-2, AN ORDINANCE ESTABLISHING MAXIMUM SPEED LIMITS ON CERTAIN STREETS, AS AMENDED

WHEREAS, on September 7, 1988, the Board of Supervisors of Heidelberg Township, York County, Pennsylvania, enacted Ordinance No. 88-2, An Ordinance Establishing Maximum Speed Limits on Certain Streets; and

WHEREAS, on January 4, 1999, the Board of Supervisors of Heidelberg Township, York County, Pennsylvania, enacted an un-numbered Ordinance establishing Maximum Speed Limits on Certain Streets, supplementing Ordinance No. 88-2 by adding additional streets; and

WHEREAS, on January 4, 2010, the Board of Supervisors of Heidelberg Township, York County, Pennsylvania, enacted Ordinance No. 10-1 establishing Speed Limits on Yingling Drive and North High Rock Road; and

WHEREAS, on September 3, 2025, the Board of Supervisors of Heidelberg Township, York County, Pennsylvania, enacted Ordinance No. 2025-02, amending Ordinance No. 88-02, reducing the maximum Speed Limit on Pamadeva Road to 25 miles per hour; and

WHEREAS, the Board of Supervisors wish to amend Ordinance No. 88-2, as amended and supplemented, to update street names and maximum permitted speed limits on certain roads as indicated below; and

NOW THEREFORE, the Board of Supervisors of Heidelberg Township, York County, Pennsylvania, enacts and ordains as follows:

SECTION 1: The road previously identified as “Hillview Road” from Hoff Road to Kraft Mill Road shall be amended to be identified as “Hoff Road.” The road previously identified as “Kraft Mill Road” shall be amended to be identified as “Porter’s Road.”

SECTION 2: The following roads shall have their maximum permitted speed lowered from thirty-five miles per hour (35 mph) to twenty-five miles per hour (25 mph) and Ordinance 88-2 shall be amended accordingly:

SECTION 3: The following roads shall be added to Ordinance 88-2 and shall have a maximum permitted speed of twenty-five miles per hour (25 mph):

SECTION 4: The following roads shall be added to Ordinance 88-2 and shall have a maximum permitted speed of thirty-five miles per hour (35 mph):

- a) Glatco Lodge Road
- b) Packing House Road

SECTION 5: The speed limits set forth and established in Sections 2 thru 4 hereof have been determined in accordance with 75 Pa.C.S.A. §§ 3363 and 6109(10).

SECTION 6: The Township Roadmaster is hereby directed to post the maximum speed limits as set forth above in accordance with the posting requirements of the Pennsylvania Motor Vehicle Code.

SECTION 7: Repealer. The provisions of Ordinance No. 88-2, as amended and supplemented, which are inconsistent with this Ordinance are expressly repealed to the extent of any inconsistency.

SECTION 8: Savings Clause. In all other respects, Ordinance No. 88-2, as amended and supplemented, shall remain as enacted and ordained.

SECTION 9: Severability. The provisions of this Ordinance are severable, and if any of its sections, clauses, or sentences shall be held illegal, invalid, or unconstitutional, such provision shall not affect or impair any remaining sections, clauses, or sentences of the same.

SECTION 10: Effective Date. This Ordinance shall become effective in accordance with law.
