6. Communications

Chairman Hansen acknowledged the receipt of traffic study results on Rt 116 and Iron Ridge Road from PennDOT and their proposed corrections. If anyone is interested in a copy of that, it can be provided to you.

Chairman Hansen acknowledged the receipt of York Audubon Society Letter, in reference to the plot of land off Rt116 that the Rail Trail is interested in acquiring from the township. Solicitor Shultis stated that the note on the subdivision plan stated the property is to be donated to the Audubon Society, which never happen, the land was donated to the Township. The Township sought the Audubon Society concurrence with the potential conveyance of the property from the Township to the YCRTA and they concurred.

12. Recreation

Frank Kempf from the Rail Trail Authority gave a brief presentation and the need for the Landowner Grantee Agreement for awarding bids. Solicitor Shultis asked, if on behalf of the RTA, can Frank commit that once/if that land transfers that you assume all of the obligations as the landowner under this agreement. Frank responded, absolutely. Solicitor Shultis stated we have discussed the certain risks of signing as the landowner, those risks are remote especially considering the next item of donating the land.

Vice Chairman Bollinger made a motion, seconded by Chairman Hansen, to approve Resolution 2025-06 – authorizing the conveyance of Real Property transfer to the York County Rail Trail Authority. Motion passed 2-0.

Sandra Munez, of Pamadeva Road, discussed a road speed limit complaint on Pamadeva Road and snow plow truck operators. Vice Chairman Bollinger stated that he will look in to lowering the speed limit sign on Pamadeva Road.

Chairman Hansen noted the recommendation brought forth by the Recreation Board, repealing a prior motion made by the BOS requiring background checks for all volunteers and Park and Recreation Board members.

Vice Chairman Bollinger made a motion, seconded by Chairman Hansen, to repeal the motion made at the January 2025 BOS Meeting that all volunteers and Park and Recreation Board members assisting with the events to obtain, at the township expense, a Child Clearence Background Certificate per the recommendation from the Recreation Board. Motion passed 2-0.

13. Water

Chairman Hansen acknowledged there are 2 outstanding water bills from Quarter 4 of 2024 and the next meter read was March 5, 2025.

Chairman Hansen made a motion, seconded by Vice Chairman Bollinger, to approve Resolution 2025-07 Statewide Local Share Account Program grant for water supply system upgrades. Motion passed 2-0.

Solicitor Shultis stated that he prepared 3 different amendments to the Resolution regarding the AD HOC Advisory Water Committee.

Vice Chairman Bollinger made a motion, seconded by Chairman Hansen, to table the motion to approve Resolution 2025-05 Second Resolution Amending Resolution 2024-07 Regarding the AD HOC Advisory Water Committee. Motion passed 2-0.

Chairman Hansen made a motion, seconded by Vice Chairman Bollinger, to table the motion to appoint alternate member to the Water Committee. Motion passed 2-0.

Solicitor Shultis discussed the potential amendment to Resolution 2021-03 (Rules and Regulations regarding Public Meetings). He proposed a number of changes to the resolution; removing any regulation on recording and streaming, anyone addressing the board during public comments need only state their name, not their address, and a simple majority vote editorial change.
